**Secondary Packaging:** 32 ECT corrugated case with glue or tape closure. Case code is the Julian date of manufacture, facility ID, line number, time interval and date of expiration.

**Storage and Transport:** Dry storage at ambient temperature (50 - 80F). Do not freeze.

**Shelf Life:** 6 months, at ambient temperature 50 - 80F.
